## **REPORT OF THE AUDITOR**

Mr. Darren Chiasson, partner with MNP LLP, presented the Auditor's Report for the year ended December 31, 2023.

During 2023, MNP met with the Audit and Risk Committees on two occasions, first to review the audit plan and again to review the audit findings and the draft financial statements. The financial statements for both credit unions were available online and at the branches. MNP issued their unmodified independent auditor's report on the financial statements for both credit unions as of December 31, 2023. Mr. Chiasson advised the financial statements presented fairly, in all material respects, the financial position of the credit unions.

The Auditor's Reports for Sydney Credit Union and North Sydney Credit Union were reviewed. There were no questions for Mr. Chiasson on either Sydney's or North Sydney's reports.

In closing, Mr. Chiasson thanked management and staff for their support during the audit process and thanked the members and the Board of Directors for trusting MNP with their audit services.

# REPORT OF THE CHIEF EXECUTIVE OFFICER

Chief Executive Officer, Carol Ripley, presented the report of the Chief Executive Officer. Mrs. Ripley reviewed the key financial results for 2023 in detail for both Sydney Credit Union and North Sydney Credit Union.

The following points were noted for Sydney Credit Union:

- Membership trends have improved this year with 924 accounts opened; an increase from the 750 accounts opened in 2022.
- Loans and mortgages increased slightly in 2023.
- Deposits increased from \$270,560 million in 2022 to \$276,034 million in 2023.
- Assets increased from \$298,642 million in 2022 to \$306,740 million in 2023.
- Net income and the patronage rebate both decreased in 2023 as the patronage rebate is tied to net income.
- Write-offs in 2023 totaled \$185,911. Write-offs since 2019 have decreased significantly.

The following points were noted for North Sydney Credit Union:

- Loans and mortgages decreased slightly in 2023.
- Deposits increased slightly in 2023.
- Assets increased slightly in 2023.
- Net income and the patronage rebate both increased in 2023.
- Write-offs in North Sydney are minimal and have very little impact on the bottom line.
